### Item Descriptions

**Item 1: Unit 3 Outcome 1** – Outcome 1 contributes 20 percent of Unit 3 and is therefore written as a 20 mark SAC. The SAC begins with a case study, followed by a series of stand alone and application questions. *(Due to be distributed before beginning of Term 1 2021)*

**Item 2: Unit 3 Outcome 2** – Outcome 2 contributes 40 percent to Unit 3. Because of the size and the varying content in this outcome, this SAC has been written to allow teachers flexibility in their assessment. Teachers receive two versions when they purchase this SAC. The two versions are:

1. 40 mark SAC (covering entire outcome)
2. 2 x 20 mark SACs (splitting the outcome into two sections)

*(Due to be distributed before beginning of Term 1 2021)*

**Item 3: Unit 3 Outcome 3** – Outcome 3 contributes 40 percent to Unit 3 and is therefore written as a 40 mark SAC. This SAC is structured into Section A and Section B. Section A consists of stand-alone questions and smaller case studies. Section B is a larger case study with questions that follow. *(Due to be distributed before beginning of Term 1 2021)*

**Item 5 – Unit 4 Outcome 2** – Ready for distribution early Term 2
